A Message from ECMC CEO Jody L. Lomeo

The first quarter of 2012 has been a very busy one! In this first quarter, acute discharges were up 6.1% from the prior year and in March we had 1,003 acute discharges. This is the most discharges that we have had in one month since June of 2009. Also, inpatient surgical cases are above last year and ER visits are up 7% above the prior year. The strategy to build the ECMC Health Campus around new service lines and improve the patient experience is taking hold.

We have submitted a Certificate of Need to the Department of Health for approval of two additional operating room suites (with room for expansion to four suites) in the new building that presently houses outpatient dialysis. With our growth in Breast, Plastic and Reconstructive, Orthopaedic and Kidney Transplant surgeries in our present operating rooms, the need for this expansion is growing. Orthopaedics continues to be a driver for the quality and growth of elective care at ECMC and these new operating rooms will serve the growing need for outpatient orthopaedic surgeries and other outpatient services. You also will see on the cover of this issue of *Pulse* a great article about the growing new Plastic and Reconstructive Department at ECMC. We continue to be proud of the success of this program, the patient-centered and quality care this team delivers, and the way in which this nationally renowned group of physicians has embraced the ECMC culture and their colleagues.

We continue to work with our partners at Kaleida on a number of initiatives as well as collaborations. We are currently working with Kaleida on a partnership to bring the cardiac expertise and services of the Gates Vascular Institute (GVI) to ECMC. The goal of this service is to provide enhanced cardiac service to our Trauma program, Emergency Services, our Regional Center of Excellence for Transplantation and Kidney Care, and our over 16,000 inpatients we serve every year. ECMC physicians will be integrated into the Gates

Vascular Institute cardiac program. This single program will be under the umbrella of Great Lakes Health and ECMC and Kaleida. We will be operating one program at two sites and will be bringing the clinical leadership of both organizations together in terms of program oversight, quality outcomes and efficient operations. We will work together with our teams to develop the program and ensure quality of care at both ECMC and the GVI.

I am also pleased to report that Kaleida Health and BlueCross BlueShield of Western New York have partnered to create a new physician-led health care organization that will offer unique health insurance products to meet the needs of our community. Kaleida Health and BlueCross officials are working with the physician leadership council to develop a strong regional physician and hospital network. This regional network will include ECMC as well as Roswell Park Cancer Institute, Upper Allegheny Health System and the Center for Hospice and Palliative Care. The new network is designed to deliver care and services needed by patients that are provided by their physicians at lower costs and is supported by the partnership of the region's largest health system and insurer. The partnership will align with nearly 500 physicians and other providers across the region to develop the network.

While we have had much good news to report in 2012, we had a sad loss in our ECMC family. Recently, we lost one of the best clinicians, patient advocates, and a true ECMC ambassador, Dr. Zale Bernstein. He was a friend and a colleague to many and his loss has been felt throughout the organization. We are continuing his legacy of providing medical oncology at The Jonah Center on the first floor of our Medical Center. His partner, Dr. Logue, as well as his physician assistants and exemplary staff, will continue to serve patients. We have also recruited another physician to provide additional patient care within the practice and

we are in discussions with Roswell Park to assist us in providing clinical coverage to grow the practice.

I would like to thank those of you who once again are supporting the ECMC Lifeline Foundation and the upcoming events in May and August (*please see the Foundation section in this issue*). If you have not already done so, please consider attending or sponsoring our gala on May 12th. Our physician honoree is Dr. Philip Stegemann, Chief of Service, Orthopaedics and our nursing honoree is Rita Rivers, RN, BSN, CNOR, Nursing In-Service Instructor in the Operating Room. I cannot think of two better people to represent ECMC, our mission and the patients we serve. They are true professionals who provide the quality of care and compassion our patients have come to expect. I congratulate and extend thanks to Dr. Stegemann and Rita Rivers. I also look forward to seeing you on May 12th.

I would like to publicly thank all of our staff members for the outstanding work they perform to serve the patients of our community. I continue to hear from physicians, community leaders, former patients and others about how impressed they are with the patient-centered culture at ECMC.

Center of Excellence in Plastic and Reconstructive Surgery at ECMC *Specializing in Head & Neck Cancer, Plastic & Reconstructive Surgery, and Breast Care*



World-renowned specialists at ECMC work collaboratively to accurately diagnose and treat conditions.

Consultation and Diagnosis: Patients who receive referrals for a head and neck specialist from their primary care doctor can schedule an initial consultation with an ECMC specialist. After a thorough examination, the specialist will deliberate with a multidisciplinary team—which may include specialists in oncology, endocrinology, radiology, pathology, oral surgery, deep inferior epigastric perforator (DIEP) flaps and reconstructive surgery—to determine an appropriate diagnostic study and then devise a safe and effective treatment plan to meet each patient's particular needs. This team approach ensures that patients receive the best and most comprehensive medical care at each stage of diagnosis and treatment.

Head and Neck Oncology: Cancers of the head and neck commonly originate in the mucosal linings of the mouth, sinuses, or throat, causing symptoms that can seriously disrupt quality of life. Though potentially aggressive, cancers of the head and neck are highly curable if detected early, and are often treated by a combination of surgery, radiation therapy, and chemotherapy. ECMC utilizes advanced medical technology to help preserve vital biological processes and give you the best chance of survival.

Microvascular Reconstruction: ECMC surgeons are also highly skilled in the practice of microvascular reconstructive surgery, which relies on high-powered microscopic technology. This technology provides access to the tiny structures, blood vessels, and nerves that is required for complex reconstructive procedures, such as tissue transfers, bone grafts, and structure replantation.

Plastics and Reconstruction

Plastic surgery and reconstructive surgery are complementary medical disciplines that address the repair and restoration of both normal function and appearance to abnormalities of the body. These abnormalities may be congenital in

nature or the result of trauma, infection, disease, or tumor. In the hands of professionals, plastic and reconstructive surgery can help reestablish a sense of normalcy in the lives of cancer and trauma patients.

At ECMC, nationally renowned plastic and reconstructive surgeons perform a variety of procedures to treat abnormalities and conditions of the head and neck, breast, and other body regions. These include:

- Breast reconstruction, utilizing both autologous (using the patient's own tissue to restore the breast) techniques such as DIEP (Deep Inferior Epigastric artery Perforator) flaps as well as tissue expander / implant techniques, depending on each individual patient's needs
- Microvascular free tissue transfer "Free Flaps" as well as a wide variety of local and regional flaps for improved functional and cosmetic outcomes in cancer and trauma patients
- Skin cancer management and reconstruction
- Restoration or improvement of form and function for cancer, trauma, and congenital abnormalities

The head & neck / plastic & reconstruction surgeons at ECMC are committed to offering world-class compassionate care from initial consultation through post-operative follow-up. They are sensitive to the emotional toll of cancer and traumatic defects and work to promote the restoration of form and function.

She completed her surgery specialty training at the University at Buffalo, The State University of New York School of Medicine & Biomedical Sciences and UB-affiliated hospitals and is currently a volunteer professor of surgery at UB. Dr. Lindfield is a national speaker on the topic of genetic testing and has also lectured extensively on topics related to breast cancer and breast care. She is a member of the American Society of Breast Disease, the American Society of Breast Surgeons, the Buffalo Surgical Society, and the Erie County Medical Society.

Breast Health Services at ECMC

Patients with breast problems can be thoroughly examined and treated by a breast specialist through ECMC's **Breast Health Services**. All breast patients can be referred to these services for specialized care if a physician or other health care professional finds any area of concern during an exam or if a patient discovers something irregular during a self examination. Services are available to all patients regardless of whether or not they have a referring physician.

Treatment and services include:

- Evaluation and management of breast disorders
- Examinations by a breast surgeon
- Treatment for pain or mastitis
- Mammograms, ultrasound, biopsies and other diagnostic procedures

Patients (both women and men) may also be referred for breast health services by ECMC physicians or through a community clinic, Planned Parenthood, or other agency. Patients with any type of breast disorder—not just a concern about cancer—are encouraged to take advantage of these services. Dr. Vivian Lindfield is Director of ECMC Breast Health Services, a board certified surgeon and assistant clinical professor of surgery at UB.

“We want to extend breast health services to as many women and men as possible,” says Dr. Lindfield. “This is a resource to reach more people in need of attention for breast disorders.”

Cancer care with a personalized approach for each patient

At the **Jonah Center for Oncology and Hematology at ECMC**, cancer specialists offer expert clinical care in a newly designed facility that emphasizes aesthetic principles in a healing atmosphere. A collaborative team of university-based and private physicians discuss each case in a group setting, reviewing pathology, radiography, and laboratory data to develop a comprehensive clinical approach for each patient. All ancillary services (laboratory, radiology, surgical, podiatric, physical therapy, occupational therapy, and rehabilitation medicine) are located on site for convenient and efficient care. The Jonah Center for Oncology and Hematology at ECMC is staffed by a dedicated team consisting of hematologists, oncologists, physician assistants, oncology nursing society-certified registered nurses, outreach coordinators, and a dedicated support staff.

Integrative approaches and cutting edge research

By integrating a range of approaches, established therapeutic modalities are explored and encouraged at the Center for Cancer Care. Throughout treatment, the patient's well being is at the core of this program. Clinical research is also an important component. Through participation in numerous trials, cutting edge clinical therapies are offered. Specialized health care providers – including oncology trained physician assistants and registered nurses – are dedicated to this core aspect of the center.

Zale P. Bernstein, MD
10/1/48-3/21/12

A graduate of the George Washington University School of Medicine, Dr. Bernstein served as Medical Oncologist and Director of the Center for HIV-Related Malignancies at Roswell Park Cancer Institute and was Chief of the Hematology Oncology Section and Medical Director of the Center for Cancer Care and Immuno Blood Conditions at ECMC. He was a Professor of Clinical Medicine and the Program Director of the Fellowship in Hematology in the Department of Medicine at University at Buffalo, State University of New York, and was an attending physician at the Roswell Park Cancer Institute. Dr. Bernstein was certified by the American Board of Internal Medicine with subspecialty certifications in hematology and medical oncology, fellowship trained in transfusion medicine, and a specialist in the treatment of Gaucher's disease, a rare blood disorder. He held a laboratory manager's license

in hematology and transfusion medicine from the State of New York. Dr. Bernstein was a well known national lecturer on a variety of topics related to hematology and oncology. He appeared frequently on radio and television programs to discuss various medical issues.

Dr. Zale Bernstein, hematologist, oncologist, poet

Dr. Bernstein died Wednesday March 21, 2012 in Hospice Buffalo, Cheektowaga, surrounded by family, after his 15-month battle with cancer. He was 63.

Dr. Bernstein loved getting a rise out of people, but patients and co-workers also knew his compassionate side. That's why mourners at his graveside service in March could be seen both laughing and crying.

His son, Ezra, said his father used metaphors to help simplify the often-complex details of the disease.

A Brooklyn native, Dr. Bernstein earned degrees from City College of New York and George

Washington University Medical Center before coming to Buffalo.

Besides Roswell Park, Dr. Bernstein worked at Erie County Medical Center, where he established the Jonah Center for Cancer Care. He also treated AIDS patients and did early research on the disease.

His passions, besides his family, were writing poetry and taking photos. After his teenage son Jonah died in an accident in 1998, Dr. Zale P. Bernstein channeled his grief into one of his longtime passions, writing poetry. A couple of years later, he put the Jonah Poems onto a CD, accompanied by recorded music. That was one side of Dr. Bernstein, the creative and sensitive side of a man who spent his professional life working with cancer patients, as remembered by his wife of 30 years, Dr. Barbara Segal and his daughter, Rachel.

A memorial service will be held later, probably in late May.

ECMC, Kaleida to Create Center of Excellence for Behavioral Health Care

Apply to state for new psychiatric and chemical dependency health facility



On February 13, 2012, Erie County Medical Center and Kaleida Health announced a joint state application for funding to help consolidate mental health and drug dependency treatment in one \$35 million Regional Behavioral Health Center of Excellence at ECMC.

The new center, a physician-driven collaboration between ECMC and Kaleida, would create a state-of-the-art, comprehensive psychiatric emergency program and new inpatient facilities to serve mental health patients in the Western New York community. Steven L. Dubovsky, MD, Professor and Chairman of Psychiatry, School of Medicine, SUNY at Buffalo, has pledged his support of the application to create the Center of Excellence in Behavioral Health Services at ECMC. Dr. Yogesh Bakhai, ECMC Clinical Director of Psychiatry and Dr. Maria Cartagena, Medical Director, Buffalo General's Department of Inpatient Behavioral Health & Psychiatry, at Kaleida will be the physicians leading this initiative.

"The region has needed a Center of Excellence in Behavioral Health for years," said Dr. Yogesh Bakhai, ECMC Clinical Director of Psychiatry. "Not only do we need to expand our facilities to meet the growing demand, we need to bring together the talents of the region to focus on creating a better model for our patients."

"This project is solely about the needs of patients. We recognize that creating exceptional quality care for our patients is not necessarily about a particular location, but about the dedication and expertise of the treatment team," said Dr. Maria Cartagena, Chief of Psychiatry, Kaleida Health and Medical Director, Buffalo General's Department of Inpatient Behavioral Health & Psychiatry at Kaleida. "As a regional center for psychiatric care, ECMC has the facility and the room to expand our comprehensive services. Additionally, this would allow us to bring the expertise of our physicians and staff together with ECMC's experienced physicians

and staff to create a true collaborative effort. The development of a center of excellence in Psychiatry would most definitely improve the quality of care for behavioral health patients for generations to come."

The consolidated model will combine the resources of the ECMC and Buffalo General Medical Center behavioral health programs and will create one 180-bed inpatient psychiatric program, as well as continue ECMC's current 22 detoxification beds and 20 inpatient chemical dependency rehabilitation beds. The plan also calls for continuing ECMC's and Kaleida's Main Street outpatient clinics, along with clinics in Lancaster and North Buffalo. The total cost of the Center, \$35 million, would be supported largely by the request to the state for Healthcare Efficiency and Affordability Law-21 funding

totaling \$25 million. ECMC Corporation and Kaleida Health will fund the remaining \$10 million. The new center, planned to open in March 2014, would expand ECMC's current emergency behavioral health facilities from 6,500 square feet to 16,000 square feet.

"The vision for this collaboration is driven by a desire to help our patients by creating a Center of Excellence for treatment of the mentally ill and

chemically dependent. This is precisely the sort of collaborative thinking that will advance this community," said ECMC CEO Jody L. Lomeo. "It also provides an opportunity to develop cost-effective, consolidated programs of emergency, outpatient, and inpatient services with one focus: the patients. It will be state of the art, and will deliver the care the mentally ill in our community deserve."

Mental health care in Western New York, like the rest of the state, is fragmented and costly to the state's Medicaid payment system. In the last 20 years, the Buffalo Psychiatric Center went from 1,200 beds to 160 and the Gowanda Psychiatric and West Seneca Developmental centers closed. Other inpatient facilities have downsized or closed in recent years and while outpatient services exist, there is a lack of coordination among community providers. Psychiatrists are also in short supply throughout the region. It has created a crisis for mental health patients and their families in Western New York. Mentally ill and chemically dependent patients in crisis are, many times, forced to find care in crowded hospital emergency rooms, which leads to more costly episodic inpatient care and unsafe conditions for clinical staff.

"This important collaboration is a creative solution to delivering care that benefits patients and brings them the very best care," said Kaleida CEO James Kaskie. "This is yet another tangible example of leveraging the talents, infrastructure, clinical expertise of both ECMC and Kaleida to benefit our community and the patients we serve."

The integrated model will combine the current outpatient volumes of 44,300 annual visits at ECMC and Kaleida's 68,829 annual visits with services provided onsite at ECMC and at their community-based locations.

Currently, ECMC has 132 licensed inpatient psychiatric beds with 2,297 annual discharges in 2011 and 57 inpatient rehabilitation/detoxification beds with 1,621 discharges in 2011. Buffalo General Medical Center has 91 licensed inpatient beds with 2,307 annual discharges.

This consolidation represents the third major initiative of Great Lakes Health System of WNY to merge the services of ECMCC and Kaleida Health. The first was the creation of the Gates Vascular Institute on the Buffalo Niagara Medical Campus in collaboration with the University at Buffalo and the second being the Regional Center of Excellence for Transplantation & Kidney Care on ECMC's campus, both HEAL funded initiatives to restructure and right size health care in WNY.



ECMC's wound care team includes the best specialists in vascular, surgical, podiatric medicine, and now infectious disease," explained Elizabeth Engler, Program Director, Wound Care and Hyperbaric Medicine Center at ECMC. "As a comprehensive Center of

Excellence, ECMC's wound care service model is truly patient-centered with convenient patient accessibility and excellent care management enabling the best outcomes possible. We anticipate that this service structure will result in increased, responsive patient referrals so wounds can be healed before more serious complications arise."

Dedicated in February of 2011, ECMC formally opened the Wound Care and Hyperbaric Medicine Center to speed healing for trauma, surgical, diabetes and other patients with slow-healing wounds in a unique facility for Western New York. The ECMC Wound Center, built in response to closure and consolidation of facilities at Millard Fillmore Gates Circle and ECMC, is a new, state-of-the-art center, currently with two hyperbaric chambers, expandable to house additional chambers as patient volume increases. The Center helps wound patients before ulcers and injuries lead to amputations. The hyperbaric chambers each hold a reclined patient who communicates by phone with a technician. Patients can watch television and DVDs through an acrylic dome or listen to piped-in music. A surgeon specially trained in hyperbaric healing is available for the start and end of each treatment, as well as to treat the wounds themselves.

Hyperbaric oxygen therapy involves putting a patient in a pressurized chamber daily with 100 percent oxygen for a length of time over weeks, depending on the wound. The effect of the pressure two levels below sea level is to open blood vessels, improve circulation and deliver enriched oxygenated blood to wound sites, enhancing and speeding healing. The feeling is like an airplane descending to land. If diabetics and trauma patients with wounds can heal faster and more effectively, short- and long-term treatment costs are less, further complications are limited or avoided, and patients can live healthier lives.

Nearly 24 million people, 8 percent of the American population, have diabetes and 15 percent of those with the disease will develop chronic wounds.

department. DCS's experience treating more than two million wounds over 20 years in some 300 hospitals shows that its centers traditionally achieve excellent clinical outcomes. These include high limb recovery rates, an 88 percent healing rate within 31 median days-to-heal, and extremely high patient satisfaction.

Moving Beyond Health Disparity and Achieving Health Equity



Continuous Renal Replacement Therapy Initiated

The concept behind Continuous Renal Replacement Therapy (CRRT) is to dialyze patients in a more physiological way, slowly over 24 hours, similarly to the way in which the kidneys function. It is a labor intensive nursing procedure which allows for gentle removal of toxins and fluid in patients with compromised renal function whose cardiovascular system may not tolerate other forms of dialysis.

This past fall, RNs throughout critical care volunteered to be part of ECMC's CRRT initiative. On February 3, 2012, the CRRT program began in the Trauma Intensive Care Unit (TICU). Implementing CRRT in the TICU setting has not been a small undertaking. The initiative, directed by Dr. James Farry, has been an example of multidisciplinary collaboration. It necessitated a thorough needs assessment and thoughtful decision-making process about program requirements, as well as a strong commitment from clinical and administrative

leadership. A core team of individuals from various departments including critical care, nephrology, hemodialysis, pharmacy and purchasing worked to make this patient treatment option a reality.

The enthusiasm and dedication of those who stepped up to share their clinical expertise during initial CRRT program implementation was remarkable. Thanks to all staff members involved in this initiative for your hard work and commitment!

What is HEALTHeLINK?

HEALTHeLINK, Western New York's clinical information exchange, is a collaborative effort among the region's leading health care organizations and private practice physicians to share clinical information in efficient and meaningful ways to improve the delivery of care, enhance outcomes, and help control health care costs throughout the region.

By providing access to your health records through HEALTHeLINK, physicians and approved medical staff members who are involved in your care, will have instant access to your most current health information. That access could improve the quality of your care and save money through the elimination of duplicate testing. Access to important medical information is also critical in emergency situations when your medical history can speak for you, even if you can't.

Your HEALTHeLINK consent could save your life

Imagine you are lying unconscious in the emergency room and the attending physician has no knowledge of your medical history. In an instant your electronic medical record becomes your voice as the physician is able to access your clinical information and quickly treat you, avoiding harmful drug interactions or other complications.

While this is one extreme instance of the value of health information technology, HEALTHeLINK allows the physicians treating you to work together and to better coordinate your care. For example, when you visit your primary care physician office, they are able to immediately access any radiology reports, lab results or medications that may have been ordered by a specialist. In addition, with instant access to

recent results, your physician may not need to send you for additional tests, saving time, money and potentially unnecessary radiation exposure.

Cleve-Hill Allscripts implementation

Cleve-Hill Family Health Center embarked on a monumental journey on August 2nd, 2011. On this day, Cleve-Hill, ECMC's community-based Family Medicine practice, successfully went live with a fully provisioned Electronic Medical Record (EMR) called, Allscripts. Cleve-Hill was chosen as the pilot site because it is a self contained clinic with its own charts and patient scheduling.


To ensure success in this complex project, the Cleve-Hill implementation core team, led by the Project Manager, Rose Mammen, concentrated on the "three Ts" - Team, Technology and Tactics. Team refers to people and organizational issues; tactics refers to specific techniques and choices made in design and setup; and technology refers to the software, hardware and network choices made. This was a major roll-out of all modules in Allscripts including: Schedule (Meditech to Allscripts Interface), Problem Lists (compilation of clinically relevant physical and diagnostic concerns, procedures, and psychosocial and cultural issues that may affect the health status and care of patients), Computerized Physician Order Entry (CPOE), Structured Provider Notes, E-prescribing, Medication and Immunization Administration, Tasking, Call Processing, Worklists, Nursing Note, Discharge Process, Results Verification, Scanning/Document Management, Patient Check-In, and Meaningful Use - Stimulus Reporting (Centers for Medicaid & Medicare Services [CMS] requires ECMC to report for scheduled periods of time to ensure the EMR has been implemented correctly and mandated measures are utilized properly for better patient care).

The implementation team set out to first understand the capabilities of Allscripts and determined how it can be used to streamline and improve current paper-based clinic processes. Using Allscripts at Cleve-Hill required that changes be made in the way tasks are performed and the persons performing the tasks. The clinical lead, Therese Aquilina, R.N., was instrumental in initiating the changes necessary for the Allscripts implementation and for office efficiency. Excellent communication and an explicit decision making process promoted the success of the upgrade.

"Super Users" were engaged from the onset to prepare them for the workflow changes. These individuals then championed the cause through the rest of the clinic to ensure that the information was disseminated in the correct context. "Super Physician Champion" Dr. Smita Bakhai and "Site Physician Champions" Dr. Ranjit Singh and Dr. Khalid Malik were engaged to decide on Chart Structure (documents from

the paper chart that were to be scanned) and CareGuides. The "Physician Champions" were instrumental in taking ownership of enterprise level decisions for workflow reconfiguration. The clinic was abuzz with the changes and workflows in anticipation of "go-live". With that in mind, it was a unified effort among the Cleve-Hill staff, ambulatory administration, and Healthcare Information Systems (HIS).

HIS updated the infrastructure at Cleve-Hill to ensure success for this endeavor. Some of the updates included the installation of 10 GB dark fiber for faster connectivity, strengthening of the access points for wireless connectivity, installation of new data ports and a network bandwidth upgrade, among others. All of these efforts were to ensure that the Cleve-Hill staff members can quickly and easily access the information on their new laptops. Laptops were chosen to give the clinicians and other staff members, mobility and easy access to patient information while interacting with patients.

Cleve Hill patient charts pre Go-Live with Allscripts

The Cleve-Hill implementation was a great success and this is mainly due to the end-users at Cleve-Hill who continue to use Allscripts the way it should be used. While all conversions like this are difficult, staff and physicians persevere every day to do the right thing using Allscripts. Their patience and tenacity during this transitional phase is quite inspirational. Since the Cleve-Hill staff members were first to bravely take on this conversion, their experiences are valuable lessons to learn from for the next clinics to "go-live" with Allscripts.

Cleve-Hill offers comprehensive care for the entire family, including newborns, children, adults, and seniors. The facility has its own draw station on site for blood work and urinalysis. 

Dr. Stegemann is a humble man, who is much more comfortable talking about ECMC than himself. He has worked at other hospitals but prefers the camaraderie he finds at ECMC. From administration, to nursing staff, support personnel, x-ray technologists, physical therapy, and plant operations, Dr. Stegemann describes an atmosphere of collegiality. In addition to being a surgeon, Dr. Stegemann teaches and trains medical students and residents. The 1989 recipient, Dr. John Border, his first mentor at ECMC; the 1992 recipient, Dr. Theodore Papademetriou, whom he credits with teaching him the skill of logical thinking; the 1995 recipient, Dr. Roger Seibel, who taught him commitment to patient care; and the 2004 recipient, Dr. Lawrence Bone, present Chairman of Orthopaedics and a close friend.





Life in the year 2100

As published in The New Yorker, The Week, April 8, 2011, by the turn of the century, says physicist Michio Kaku, and based on interviews with 300 of the world's top scientists, Kaku assembled some predictions for what that world, 100 years in the future, will look like.

In various issues of ECMC Pulse, we'll publish some of these predictions.

One of these predictions is described below.

Doctors will be able to grow 'spare parts' for our organs as they wear out.

This will create a "human body shop." We will never need organ donors and will never die of organ failure. Even the typical doctor's visit will change. By mid-century, doctors and scientists may be able to construct an entire organism using its genome alone. As this genome science progresses, researchers may be able to carry a small kit around with them and, in mere minutes, sequence the entire genome of any life-form they encounter. We will then be able to resurrect extinct life-forms, such as the mammoth, dodo bird, and even the Neanderthal. (There are ethical concerns with the Neanderthal. As one scientist asked, "Do we put them in a zoo or put them through college?") In the movie Jurassic Park, scientists extracted DNA from dinosaurs and inserted it into the eggs of reptiles. Although usable DNA from dinosaurs has yet to be found, there is evidence that in the future this dream might become a reality. That means by the end of this century, our zoos may be populated by creatures that ceased walking the surface of the earth millions of years ago.
