#### CEO Tom Quatroche Joined Governor Cuomo after Ride for Breast Cancer Screening.






Since ECMC Foundation's Mobile Mammography Coach was launched in 2012:


- Over 10,000 women have been screened on the coach
- 21 women were found to have breast cancer
- 987 women were identified as needing additional diagnostic imaging and case management after coach screening

- The 2016 Women's Choice Award® as one of America's Best Hospitals for Patient Safety. This evidence-based designation is the only patient safety award that identifies the country's best healthcare institutions based on robust criteria that considers female patient satisfaction and clinical excellence.
- The Leapfrog Group, an independent, national not-for-profit organization founded more than a decade ago by the nation's leading employers and private health care experts, rated ECMC's overall safety score at 'B', which places it among 638 other hospitals across the country receiving such a score.

#### New York State Amends Historic ECMCC Act To Promote Collaboration

Erie County Medical Center Corporation (ECMCC) applauded Governor Andrew M. Cuomo for recently signing into law an amendment to the state public authorities' law, permitting ECMCC to enter into agreements for the creation and operation of an integrated health care delivery services in collaboration with Kaleida Health and the University at Buffalo.

The legislation, sponsored by Assemblywoman Crystal Peoples-Stokes and Senator Michael Ranzenhofer, amended a 2003 state law that had created the Erie County Medical Center Corporation as a standalone public benefit corporation.

Great Lakes Health System of WNY Chairman Robert D. Gioia said, "This critically important amendment ensures that the progress made by Great Lakes Health will continue to the next level, fostering activities that will improve the quality of, and access to, healthcare services. We thank Assemblywoman Crystal Peoples-Stokes and Senator Michael Ranzenhofer for sponsoring this legislation and Governor Cuomo for signing it into law."

ECMCC Chair Sharon L. Hanson said, "Working collaboratively with partners like Kaleida Health and the University at Buffalo to support, strengthen and reinforce all aspects of the services we provide to a diverse and dynamic Western New York population benefits everyone. Thanks to Governor Cuomo, Assemblywoman Peoples-Stokes and Senator Ranzenhofer for leading Western New York forward in this way."

ECMCC President and CEO Thomas J. Quatroche, Jr., Ph.D. said, "This outcome is the result of the dedicated hard work of many, but would not have come about without the leadership of Governor Cuomo, Assemblywoman Peoples-Stokes and Senator Ranzenhofer. ECMCC and its partners, Kaleida Health and the University at Buffalo, are committed to providing the highest quality care and this amendment will facilitate further those efforts."

Great Lakes Health and Kaleida Health
President and CEO Jody Lomeo said,
"The change in the PBC law is a win for our
community. Together, we can continue to
collaborate and strengthen our ability to
coordinate care while continuing to fulfill our
mission. With the help of Governor Cuomo,
Assemblywoman Peoples-Stokes, Senator
Ranzenhofer and the State Legislature, we are
improving the delivery of care across Western
New York and making it better for the patients
we serve."

University at Buffalo President Satish Tripathi said, "Our UB community is grateful to

Governor Cuomo, Assemblywoman Peoples-Stokes, and Senator Ranzenhofer for their leadership on this amendment, which represents a vital step forward for the thriving life sciences economy we are building together in Western New York. Together, our region's great health care and research institutions are collaborating to establish Buffalo as a world-class destination for the best in patient care, clinical research, and medical education. This amendment significantly advances those efforts, and UB looks forward to partnering with ECMCC and Kaleida Health to ensure exceptional health care delivery for our communities."

It is important to note that the amendment does not change ECMCC's governance structure or relationship with its union partners. ECMCC is, and will remain, a public institution with a public workforce and its own balance sheet.

#### The amendment allows for:

- Development of a non-exclusive joint health information technology (IT) platform
- Joint marketing of health care services
- Joint purchasing of services, supplies and equipment
- Development of a joint set of clinical quality standards
- Coordination and integration of clinical services to reduce redundancy and increase efficiency
- Joint management of graduate medical education and academic affiliations
- Joint discussions with rural hospitals regarding the possibility of coordinating and integrating clinical services

Most importantly, the amendment gives ECMCC the ability to lower costs and improve quality and access to health care in Western New York.

This amendment strengthens ECMCC's continuing development of Centers of Excellence in areas such as Orthopaedics, Behavioral Health and Transplantation, as well as the growth and development of other important health service lines like Cancer Care, Head and Neck Surgery, Bariatrics, and Dental Oncology. This past year (2015) was the busiest year in ECMCC's history, and through the first quarter of 2016, ECMCC continues to grow and build on that positive trend.

The three institutions affected by this amendment have been collaborating since 2008, as a result of the recommendations made by the Commission on Health Care Facilities in the 21st Century (Berger Commission).

Amendment identifies several initiatives allowing ECMCC, Kaleida Health & the University at Buffalo to continue progress under Great Lakes

As a free standing public health care provider, ECMCC is at a competitive disadvantage in the current health care environment. Recent U.S. Supreme Court rulings restricted the extent to which ECMCC could collaborate. The amendment to state law changes that by leveling the playing field for ECMCC to enter into agreements like those of other health systems while maintaining its public status.

The amendment provides a physician-led solution that will permit ECMCC to pursue further initiatives intended to improve health care quality and access, while maintaining ECMCC's public character and purposes, its public workforce and its own balance sheet.

ECMCC has been a leader in coordinating clinical service planning across Western New York. Along with Kaleida Health, UB, and their private practice physicians, they have created centers of excellence around transplant, cardiac, behavioral health and laboratory services.

#### Survey data confirms ECMC's Patient Satisfaction keeps going up

HCAHPS (Hospital Consumer Assessment of Healthcare Providers and Systems) is a standardized survey which is meant to measure patients' perspectives on hospital care. The survey gains insight on the patient experience in the following areas: communication with nurses, responsiveness of hospital staff, communication with doctors, the hospital environment, pain management, communication about medicines, discharge information, and care transitions. It is comprised of 32 questions and is administered to a random sample of discharged patients. The standardization of survey questions and administration methodology allows for comparison between hospitals and across the nation.

One use of the HCAHPS survey results is for CMS Value Based Purchasing purposes. Hospitals are compared to the national 50th (Threshold) and 90th (Benchmark) percentiles of data collected two years prior to the reporting period. The data collected during the 2015 calendar year determined 25% of the Value

Based Purchasing payment amount for the hospital. The data below shows ECMC's consistent improvement across all measures from 2012 through 3rd quarter 2015.


Over the last several years, ECMC has refocused its commitment to the patient experience journey. Many patient-centered initiatives have been put in place to lay the foundation for growth, sustainability and accountably in this area. Our Nursing Department and executive leaders have dedicated time to patient and teammate "rounding" (visits). This gives the nursing team dedicated time to focus on the unit and drill down to address any patient opportunities. The executive leadership is also out on units and rounding within various departments to talk with patients, families and teammates. In addition to the Nursing and Executive Leadership teams, we have several Patient Advocates who work on the units and in the Emergency Department to also re-enforce the team work and support the needs of the patients in whatever way possible.



#### ECMC recognized with Quality Achievement Award & Honor Roll



Erie County Medical Center Corporation recently received the Get With The Guidelines®—Heart Failure Gold-Plus Quality Achievement Award for implementing specific quality improvement measures outlined by the American Heart Association/American College of Cardiology Foundation's secondary prevention guidelines for patients with heart failure. This marks the 10th year that ECMC has been recognized with a quality achievement award.

Get With The Guidelines—Heart Failure is a quality improvement program that helps hospital teams provide the most up-to-date, research-based guidelines with the goal of speeding recovery and reducing hospital readmissions for heart failure patients.

Launched in 2005, numerous published studies have demonstrated the program's success in achieving patient outcome improvements, including reductions in 30-day readmissions.

ECMC earned the award by meeting specific quality achievement measures for the diagnosis and treatment of heart failure patients at a set level for a designated period. These measures include evaluation of the patient, proper use of medications and aggressive risk-reduction therapies. These would include ACE inhibitors/ARBs, beta-blockers, diuretics, anticoagulants, and other appropriate therapies. Before patients are discharged, they also receive education on managing their heart failure and overall health, have a follow-up visit scheduled, as well as other care transition interventions.

ECMC also received the association's Target: Heart Failure Honor Roll. Target: Heart Failure is an initiative that provides hospitals with educational tools, prevention programs and treatment guidelines designed to reduce the risk of heart failure patients ending up back in the hospital. Hospitals are required to meet criteria that improves medication adherence, provides early follow-up care and coordination and enhances patient education. The goal is to reduce hospital readmissions and help patients improve their quality of life in managing this chronic condition.

According to the American Heart Association, about 5.7 million adults in the United States suffer from heart failure, with the number expected to rise to eight million by 2030. Statistics show that each year about 870,000 new cases are diagnosed and about 50 percent of those diagnosed will die within five years. However, many heart failure patients can lead a full, enjoyable life when their condition is managed with proper medications or devices and with healthy lifestyle changes.

Hospitals that have earned this award have had a low incidence of problems arising from surgical errors and infections. The hospitals that report their frequency to The Centers for Medicare and Medicaid Services (CMS) are ranked for each of the following eleven measures:

- 1. Deaths among patients with serious treatable complications after surgery,
- 2. Collapsed lung due to medical treatment,
- 3. Serious blood clots after surgery,
- 4. A wound that splits open after surgery on the abdomen or pelvis,
- 5. Accidental cuts and tears from medical treatment,
- 6. Serious complications,
- 7. Central line-associated blood stream infections (CLABSI),
- 8. Catheter-Associated Urinary Tract Infections (CAUTI),
- 9. Surgical Site Infection from colon surgery (SSI: Colon),
- Methicillin-resistant Staphylococcus Aureus (MRSA) blood laboratory-identified events (bloodstream infections), and
- 11. Clostridium difficile (C.diff.) laboratoryidentified events (intestinal infections).



#### Hospitals can be eliminated from consideration for the following reasons:

- Not reporting on at least 4 of the surgical complication measures (1-6) or 4 of the infection measures (7-11),
- Having a patient recommendation rating in the bottom 25% nationally,
- Receiving a CMS rating of "Worse than the U.S. National Rate" for any of the above measures
- Not implementing Safe Surgery Checklists.

For the remaining hospitals, the Women's Choice Award (WCA) averaged their rankings for all the measures (weighted slightly toward surgical errors as a result of the WCA's women's survey) and cut off the award list only including those that averaged in the top half nationally.

Established in 1969, The Joint Commission's Behavioral Health Care Accreditation program currently accredits more than 2,250


organizations for a three-year period.

#### ECMC Opens New, State-Of-The-Art Center for Orthopaedic Care

On April 7th, the Erie County Medical Center dedicated its new, state of-the-art Center for Orthopaedic Care, which includes 14 spacious exam rooms (double what had existed previously) and new safety features and improved patient amenities designed to ensure a better overall patient experience. The new 6,900 square foot Center is nearly four times larger than the hospital's former orthopaedic clinic, which opened in 1978.

In February 2015, members of ECMC's Executive Leadership, Orthopaedics and Ambulatory Services finalized plans to do a complete overhaul of ECMC's orthopaedic clinic, moving it to a new location on the hospital's first floor, emphasizing the goal of improving care for our patients. From 2000 to 2010, patient visits to the former orthopaedic clinic increased by approximately 46% and between 2010 and 2015, 57,262 patient visits occurred at that location.

Sharon L. Hanson, Chair, Erie County Medical Center Corporation (ECMCC) Board of Directors said, "Together with the Salvatore Orthopaedic Unit that opened last year, our new Center for Orthopaedic Care brings the highest level of outpatient orthopaedic care to patients throughout Western New York. This new facility has nearly double the number of exam rooms and all corridors feature handrails for patient safety and convenience. The unit's upgrades also include dedicated physician and nurse work areas and spacious registration and checkout areas for patient convenience, helping to ensure that our patients' experience meets their expectations."

Caregivers from Orthopaedics and Ambulatory Services collaborated on a Lean Six Sigma project dedicated to resolving various issues affecting their patients, including wait times, helping to design the new outpatient Center to improve service and enhance efficiency. Lean Six Sigma is a methodology that relies on a collaborative team effort to improve performance by systematically removing waste. The outcome is the new modern, state-of-the-art facility that replaces a cramped, outmoded inefficient space that did not meet the needs of patients, physicians, clinical caregivers or the important teaching of residents.

President and CEO said, "Patient experience is our highest priority and this new Center for Orthopaedic Care provides another demonstration of ECMC's commitment to the highest possible healthcare for anyone who seeks our services. This new facility, combined with our inpatient Russell J. Salvatore
Orthopaedic Unit and the Ambulatory Surgery Center, provides orthopaedic patients the best

possible experience along the entire continuum of care. A positive patient experience and quality services are essential aspects of our overall delivery of healthcare services, which are reflected among the over 3,000 exceptional and skilled caregivers who everyday work to meet the needs of our patients."

Dr. Philip Stegemann, Chief of ECMC
Orthopaedics said, "ECMC is a special place, with dedicated caregivers, physicians, and now we have a beautiful new environment in this well-designed Center for Orthopaedic Care, which is conducive to healing for our patients.
The patient has always been at the center of the care we deliver, and this new unit takes this level of commitment to our patients to another level.
Our mission not only involves patient care, but also education. It's an ideal space for teaching Orthopaedic Residents, medical students, nurse practitioners, and physician assistants."

Other state-of-the-art features in the Center include in-room call and code systems, improved ventilation, widened doorways to accommodate varying sizes of wheelchairs and stretchers, and secure badge entry to clinical care areas. There is also a newly created pass-through to the Radiology Department, creating ease of access and improved throughput.

Demand for elective orthopedic surgical services has grown substantially, especially among patients who need total joint replacement. During the three-year period 2011 to 2013, ECMC's total inpatient surgical volume consisted of 12,840 cases marked by substantial growth each year; i.e., a 7.5% increase from 2011 to 2013. Also for the three-year period, ECMC had 5,768 orthopedic cases (13.4% increase from 2011 to 2013) and 1,936 total joint procedures marked by a 60.4% increase from 2011 to 2013.

Over the past five years, growth in the following key areas at ECMC has occurred: Inpatient Discharges increased by 22 percent; Surgeries increased by 20 percent; Emergency Department visits increased by 16 percent; and Outpatient Visits recorded a 20 percent increase. Along with expanded clinical capabilities and an increase in services performed, ECMC has maintained a passionate commitment to the mission of high quality patient care and satisfaction.

ECMC opened the \$12.5 million Russell J.
Salvatore Orthopaedic Unit in 2015, the \$35
million consolidated behavioral health center in
2014, the \$103 million Terrace View Long-Term
Care facility in 2013, and the \$27 million
Regional Center of Excellence for
Transplantation & Kidney Care in 2012.

Manager Linda Schwab, MS, RN, as a Trauma Certified Registered Nurse (TCRN).

Schwab becomes one of the first trauma nurses in the country to take and pass the new exam to earn this credential through the BCEN. The TCRN is the first trauma-specific, national credential that designates expertise in trauma.

According to the BCEN, "The certification exam incorporates the body of knowledge in trauma nursing across the continuum of care, from injury prevention through reintegration to home.

To qualify for the exam, one must hold either a current unrestricted Registered Nurse License in the United States or its Territories, or a nursing certificate equivalent to a Registered Nurse in

the United States." BCEN also recommends an average of 1,000 practice hours per year across the trauma care continuum over a two year period before taking the exam.

Linda Schwab has served in various clinical positions during her 35 years at ECMC. As Trauma Program Manager (2004-present) she works regionally and in collaboration with statewide committees to establish trends in the incidence of traumatic accidents and to implement research-based practice changes in trauma care and public health policy. She is extensively involved in outreach education for injury prevention.

In 2007, Schwab was honored by the New York State Chapter of the American Trauma Society as the *Trauma Coordinator of Distinction for New York State*. Linda Schwab earned her Master of Science in nursing (2004) and her Bachelor of Science in nursing (1981) degrees from D'Youville College.

Since the early 1960s, ECMC has set trends in trauma and emergency care, developing practices, procedures and in some cases devices (such as the first crash cart) that have since become standards of care now implemented/utilized in hospitals across the nation and the globe. ECMC is designated a Regional Adult Trauma Center by the New York State Department of Health (2015) and Nationally Verified as a Level 1 Trauma Center by the American College of Surgeons (2015). ECMC has achieved the best trauma survival rate of all trauma centers in the State, according to a July 2006 report from the New York State Department of Health (www.health.state.ny.us). #### ECMC Now Offering Portable Hemodialysis System for Home Use

#### Home Hemodialysis Treatments Can Improve Health and Quality of Life



The ECMC Dialysis Center is pleased to announce it is now offering home hemodialysis with the NxStage System One, the only truly portable hemodialysis system cleared by the FDA for home use during the day or overnight. More patients in the community will now have the opportunity to enjoy the health and quality of life benefits of more frequent and/or longer home hemodialysis treatments.

Chronic kidney failure, also known as End-Stage Renal Disease, or ESRD, is a life-threatening condition that occurs when both kidneys are no longer able to process the body's wastes and excess fluids. To survive, ESRD patients require kidney replacement therapy for the rest of their lives either in the form of a transplant or some type of dialysis. More than 500,000 patients in the U.S. suffer from ESRD, and that number is expected to double in the next 10 to 15 years due to the alarming rise in diabetes, obesity and hypertension.

Hemodialysis, the cycling of the patient's blood through a filter and back to the patient, is the most common form of kidney replacement therapy. For the majority of people, this means going to an outpatient center three times a week for about four hours each session. This is a demanding regimen that intrudes upon family life, work and vacation planning. Although this treatment method is effective for many patients, research has shown significant health benefits can be attained from more frequent or longer duration hemodialysis, which is only logistically practical to do in the home setting. ECMC is now offering its ESRD patients this new treatment option that makes the potential benefits of home hemodialysis more attainable.

"Performing more frequent or longer dialysis in the home provides patients with better clinical outcomes as well as an improved quality of life," said Mandip Panesar, MD, Medical Director, Hemodialysis Unit, ECMC. "Patients have been very receptive to the NxStage system since it offers them the ability to perform sessions in their home, with more freedom and flexibility as to when and where they do their treatments. Because it mimics a working kidney more closely, more frequent and longer hemodialysis has been shown to reduce the stress on the heart, improve post-dialysis recovery time, better control blood pressure with fewer medications, provide improved mental and physical health, and lower the risk of death."

The NxStage System One is a compact system just over a foot high that weighs around 75 pounds. The System One is different from conventional dialysis equipment in that it is powered by a standard household outlet and uses ultra-pure dialysate prepared from ordinary tap water, eliminating the need for costly electrical and plumbing changes to the home. The System One is portable and can also be used with sterile premixed dialysate bags for travel. Many patients using the NxStage System One have benefited from the ability to travel with the system, attaining a level of freedom and independence they couldn't achieve with conventional in-center dialysis. The simplicity of NxStage System One allows therapy to be delivered by a trained patient and his or her trained partner.

#### ECMC Living Donor Transplant Probation Lifted by National Organization

## National not-for-profit, United Network for Organ Sharing, removes probation imposed in 2014

The Board of Directors of the United Network for Organ Sharing (UNOS) has unanimously approved the release of ECMC's living donor transplantation program from probation and restored all privileges for the program. The UNOS Board's action came about from the recommendation of the organization's Membership and Professional Standards Committee (MPSC), which is the UNOS regulatory body.

ECMC had been placed on probation in November 2014 by the UNOS Board "based on a need to address issues relating to its evaluation of potential living donors."

Dr. Liise Kayler, MD, MS, FACS, the Program and Surgical Director of Transplantation said, "Every member of our department has worked diligently to raise the level of excellence and quality of the services we provide to every patient that comes to us. This action by UNOS confirms the tremendous effort we have made and the continuing level of success we achieve for every procedure we perform."

ECMCC President and CEO Thomas J. Quatroche, Jr., Ph.D. said, "This is very exciting and validates our commitment to ensuring that the highest quality services are available for our patients, along with offering a great team of experienced, exceptional health care professionals who have again proved the excellence of ECMC's transplant program.

Under the leadership of Dr. Liise Kayler, MD, MS, FACS, the Program and Surgical Director of Transplantation, is poised this year to double the number of transplants performed at ECMC in 2013."

In a separate announcement, OPTN/UNOS President Betsy Walsh, J.D. said, "[ECMC] demonstrated commendable improvements in quality management and training and [has] successfully addressed the concerns that led to the earlier action."

#### ECMC joins hundreds of Organizations to Increase Colorectal Cancer Screening Rates across the Nation

March was Colorectal Cancer Awareness Month and ECMC celebrated by making the pledge to help increase colorectal cancer screening rates by supporting the 80% by 2018 initiative, led by the American Cancer Society (ACS), the Centers for Disease Control and Prevention (CDC) and the National Colorectal Cancer Roundtable (a coalition co-founded by ACS and CDC). Dr. John Fudyma, Associate Director, ECMC Corporation, joined Mayor Byron Brown and other participating representatives at Buffalo City Hall to sign the pledge.

Colorectal cancer is the nation's second-leading cause of cancer-related deaths in the U.S. when men and women are combined; however, it is one of only a few cancers that can be prevented.

Through colorectal cancer screening, doctors can find and remove hidden growths (called "polyps") in the colon, before they become cancerous.

While colorectal cancer incidence rates have dropped in the U.S. among adults 50 and older, it is still the second leading cause of cancer death in the United States, despite being highly preventable, detectable and treatable. In fact, it is estimated that in 2016, 134,490 cases of colorectal cancer will be diagnosed.

"80% by 2018" is a National Colorectal Cancer Roundtable (NCCRT) initiative to substantially reduce colorectal cancer as a major public health problem and work towards the goal of 80% of adults aged 50 and older being regularly screened for colorectal cancer by 2018. Leading public health organizations, such as NCCRT, CDC and the ACS are rallying organizations to embrace this shared goal. If the goal of 80% by 2018 goal is achieved, 277,000 cases and 203,000 colorectal cancer deaths would be prevented by 2030.

Today, more than 121,000 candidates are on the national organ transplant waiting list, and over 10% of the names on the list are from New York State. As a result, an average of 21 people die each day because an organ was not made available for transplant. A single donor can save and heal as many as 50 others through needed organs, heart valves, corneas, skin, bone and tendons.

The Regional Center of Excellence for Transplantation and Kidney Care at ECMC is the result of the merging of two transplant programs—from Buffalo General Hospital and ECMC—into a single streamlined, highly specialized program that offers patients world class care. The mission of the Center is to provide life-saving kidney and pancreas transplants, vascular access surgical care, hemodialysis for outpatients and inpatients, and treatment and disease management services for patients with all stages of chronic kidney disease. This concentration of services results in a greater number of procedures performed, a high level of expertise among the medical staff, and the most favorable outcomes for renal patients at all levels of care.

With state-of-the-art technology and procedures for transplant, as well as a growing living donor program, ECMC's transplantation team is leading the way in True Care. In 2014, 13% of our wait list patients received transplants and we achieved a 96% 1-year survival rate—outcomes more successful than competitors like

the University of Pittsburgh, Cleveland Clinic, and the University of Rochester.

## ECMC Oral Cancer Screening Program is now open to high-risk individuals.

Oral cancer is a quiet but deadly disease. Oftentimes it exhibits no symptoms until after it has spread outside the mouth, typically to the neck. The earlier these cancers can be detected, the better chances that they can be successfully treated. The ECMC Early Oral Cancer Detection and Diagnosis Screening Program is designed to detect head and neck abnormalities and cancers at the earliest and most treatable stages. Individuals at risk for head and neck cancer are currently eligible for screening as part of a research study entitled: A Biorepository and Databank for Identifying Biomarkers for Oral Cancer. The Department of Dentistry/Oral Oncology & Maxillofacial Prosthetics together with the Department of Head & Neck/Plastic & Reconstructive Surgery brings surgeons and

dentists together to better understand, prevent, and treat these types of cancers.

Anyone with a suspicious lesion in the mouth or throat or with a history of head and neck cancer who has already been treated but remains on close surveillance is eligible. Any patient with risk factors for head and neck cancer may also be eligible for the program. Those with an increased risk of head and neck cancer include people who smoke cigarettes or who use any tobacco products and drink alcohol.

Participation in the Screening Program study is strictly voluntary and participants will be asked to fill out a written informed consent form. Each participant's mouth will be examined under



normal light and any suspicious areas will be recorded. The mouth will then be examined with other imaging technology, like autofluorescence light.. Other specimens may be collected like saliva and cheek swabs. A biopsy may be taken of an area or areas that look suspicious and possibly from an area that appears completely normal. The samples may be evaluated for early markers or genetic changes that may indicate risk of cancer. All specimens and information will be stored for future research purposes but all personal identifying information will be removed and all names will be replaced by study numbers.

## The Terrace View Team shares the thoughts of Ellen Goodman on end-of-life decisions

The "Your Voice, Your Values" community outreach team at ECMC/Terrace View would like to encourage everyone to take time to talk with those you care about and give them the gift of starting the conversation about end-of-life decisions.

We'd like to share some thoughts from Ellen Goodman, award-winning national columnist and founder of The Conversation Project, about the importance of having the conversation.

"There is something both primal and intimate about the act of feasting on food and rich conversation," writes Ms. Goodman. "We share stories like heaping platters of warm pasta and pass traditions along to the next generation like salt to flavor their lives."

"Even in our fast food culture, we associate feasts and the people we love—and those we've lost—in an endless table of remembrance."

"There is no feast quite so powerful as Thanksgiving with its iconic turkey, with the side dishes and stuffing that are as particular to our families as DNA. For my family, the menu is as sacred as the lemon pie passed down from one generation to another."

"Today, when families are scattered and distracted by every type of technological intruder, the holidays still set the stage for real, intimate, and open conversations. And so, we invite you at some point over the holidays, in between football and over leftovers, after the plates are cleared and rest of the pumpkin pie has been retired to the refrigerator, to talk turkey. We invite you to break bread and taboos, and to share your wishes across the generations for how you all want to live at the end of your days."

"When we started The Conversation Project, we knew that too many people were not dying in the way that they would choose. Too many survivors were left guilty, depressed, and uncertain about whether they had done the right thing for their loved ones. It seemed that everyone had a story—a story of a good death or a hard death. The difference was often whether they had their wishes expressed and respected."

"We knew that we could make it easier. These conversations shouldn't happen in the ICU. Decisions shouldn't be left to a harried EMT or a doctor you've never met. You should decide in concert with the people you chose to speak for you if you can't speak for yourself. We need to talk at the kitchen table, before there is a crisis."

"These are often seen as hard conversations. They are as tender as love and loss. We stumble and postpone them and assure ourselves that it's too soon—often until it's too late. But we can open this up; we can make this a feast of honesty, using stories and recipes as our utensils, talking and eating together, and making this a first course of intimacy and warmth."

"Dinnertime conversation? You bet. A blessing over the turkey tetrazzini that makes up the leftover meal. Stories to tell that the children can hear about their elders and ancestors that include endings."

"We invite you to start this new tradition, to tell stories, and to think easily, deeply, and with humor and honesty about this one universal experience and its humanity. In return, we promise comfort along with comfort food."

#### Accessible Public Transportation - Don't Miss The Bus!











ECMC rehab therapists initiated a new program to assist patients in learning about and practicing the use of public transportation. In addition, there will be an NFTA Metro supervisor available for more information. This service is available for all appropriate Rehab patients. ## Historic cardiology collaboration receives state approval!

## Niagara Falls Memorial, Kaleida Health, ECMC, and Catholic Health will jointly operate cardiac catheterization laboratory in Niagara County

Four Western New York health systems have been granted state approval to implement an unprecedented collaboration that will make lifesaving cardiac care readily accessible to residents in Niagara County.

Niagara Falls Memorial Medical Center, Kaleida Health, Erie County Medical Center Corporation and Catholic Health will build and operate a cardiac catheterization laboratory ("cath lab") at The Heart Center of Niagara on Memorial's downtown Niagara Falls campus.

Plans call for ECMC to decertify one of its existing cardiac cath labs and transfer the license to the new joint venture at the Niagara Falls site. Recent approval by the Health Department's Public Health and Health Planning Council Albany will soon open the door for the partners to begin construction.

"Having a cardiac catheterization lab here will eliminate existing barriers to cardiac care and provide access to lifesaving diagnostic and therapeutic treatment close to home," said Niagara Falls Memorial President & CEO Joseph A. Ruffolo. "The leaders of the other participating health systems — Catholic Health's Joseph McDonald, Kaleida Health's Jody Lomeo and Tom Quatroche of ECMC — deserve a great deal of credit for setting competition aside and collaborating with us to do the right thing for the residents of Niagara County."

"ECMC is committed to working collaboratively with our regional healthcare partners to bring about better medical treatment for the patients we serve and provide better outcomes," said President & Chief Executive Officer Thomas J. Quatroche, Jr., PhD. "We are very pleased that New York State affirmed our focus on the patient and community, ensuring that this cardiac cath lab could be established at NFMMC and provide greater service to the residents of Niagara County."

"We are committed to the transformation of healthcare in Western New York and this project is going to have a significant impact on improving access to lifesaving cardiac care throughout the Niagara region," said Joe McDonald, President & CEO of Catholic Health. "I am pleased we were able to work collaboratively with our project partners to put the needs of area residents first."

"Today is a great day for the community, and in particular, Niagara County," said Kaleida Health President and CEO Jody Lomeo. "There was a demonstrated need and, together, we were able to leverage our collective strengths to address some of the health disparities in cardiac care. The collaboration between Niagara Falls, ECMC.

Kaleida Health and Catholic Health represents what is best for those we serve – the patients. They are the true winners here."

The cath lab project will not result in a major increase in patient volume across the Buffalo-Niagara region, but will make it more convenient for patients in Niagara County to access this specialized care closer to home. Currently, cath lab services are only available in Buffalo at ECMC, Catholic Health's Heart Center at Mercy Hospital and Kaleida Health's Gates Vascular Institute.

The Niagara County cath lab project will also enable the Western New York Performing Provider Systems to which the hospitals belong – Millennium Collaborative Care and Community Care Partners of WNY – to jointly address Delivery System Reform Incentive Program (DSRIP) projects to improve the region's cardiovascular health.

DSRIP is the statewide effort to fundamentally restructure the health care delivery system by reinvesting in the Medicaid program, with the primary goal of reducing avoidable hospital admissions by 25 percent over the next five years.

In their applications, the systems noted that heart disease is the leading cause of death in Niagara County and that significant health care disparities exist.

"African-American and Medicaid patient populations are undertreated and underserved.

Disparities also exist for other historically underserved populations such as Native Americans, mental health patients and people with developmental and intellectual disabilities," Ruffolo said.

"This project will accomplish three important objectives by eliminating barriers to care,

improving the management of cardiac disease through the use of best practices and waging a strong and sustained campaign to prevent heart disease," he added.

The \$2.18 million project will be funded through equity investments by each of the managing partners, with Kaleida Health, Catholic Health and Niagara Falls Memorial each holding 30 percent ownership, and ECMC a 10 percent interest. In addition, Memorial has been awarded a \$1.08 million grant through the NYS Capital Restructuring Finance Program that will be used to help offset the cost of cardiac catheterization equipment.

All four parities will actively participate in the cath lab's operation, appointing members to a clinical committee to manage the day-to-day operations of the facility and a management committee to oversee planning and financial operations. A medical director for the program and other physicians will be recruited from the partner hospitals.

The state's approval requires construction of the 4,145-square-foot facility to begin by July 1 and be completed by Feb. 1, 2017. The equipment selection process will begin immediately. Cardiac catheterization is a procedure for diagnosing and treating cardiovascular conditions in which a long thin tube called a catheter is inserted in an artery or vein in a patient's groin, neck or arm and threaded through the blood vessels to the heart.

The Niagara County cath lab will maintain 24/7/365 capabilities to perform emergency and scheduled elective procedures and interventions, including cardiac angiography, stent placement and balloon angioplasty.





## ECMC participating in AstraZeneca Clinical Trial Studies to Treat Head & Neck Cancer Patients with Newest Investigational Product



The Center for Oncology Care Department of Head & Neck and Plastic & Reconstructive Surgery and Medical Oncology at ECMC (Erie County Medical Center) was selected by AstraZeneca to be among the first cancer treatment providers in the nation to take part in a clinical trial with the AstraZeneca investigational product durvalumab (MEDI4736).

AstraZeneca is currently running two Phase II studies in which ECMC is participating to determine the effectiveness and safety of an investigational product in the treatment of patients with recurrent or metastatic squamous cell carcinoma of the head and neck who have progressed during or after treatment with a platinum-containing regimen for recurrent or metastatic disease.

Durvalumab is a monoclonal antibody immune checkpoint inhibitor targeting programmed cell death ligand 1 (PD-L1). Expression of PD-L1 by tumors helps tumors avoid detection by the immune system. Durvalumab blocks this signal, empowering the patient's immune system to attack the cancer. Durvalumab has demonstrated clinical activity in end stage head and neck cancer patients with both PD-L1 positive and negative tumors in phase 1 studies.

Depending on the tumor PD-L1 status, determined at screening, eligible patients will receive monotherapy with either durvalumab or tremelimumab (CTLA-4 inhibitor), or a combination of the two products for up to one year.

The clinical trials are referred to as the "HAWK" and "CONDOR" studies.

HAWK is a Phase II, single arm, multicenter global study assessing the efficacy of durvalumab monotherapy in patients who have confirmed PD-L1 positive tumors. Enrollment is currently active and competitive in nature.

CONDOR is a Phase II, randomized, 3-arm, multicenter global study. Patients with PD-L1 negative tumors may be randomized to receive either monotherapy with durvalumab or tremelimumab, or durvalumab and tremelimumab in combination. This study will assess the efficacy of both monotherapy regimens and the combination regimen in patients with PD-L1 negative tumors. Enrollment is currently active and competitive in nature.

Patients need to meet specific enrollment criteria to be eligible to participate in either study. Patients who wish to be considered as potential participants in one of these studies should ask their doctor if they could be considered as a participant. Their doctor would then refer the appropriate patient(s) to ECMC for further evaluation for possible participation in one of these studies.

"We are pleased that ECMC was selected as one of a small number of providers to participate in these trials," stated Ritesh Patil, MD, MPH, Oncologist, Jonah Center for Oncology and Hematology at ECMC; and Assistant Professor, Hematology and Oncology, Jacobs School of Medicine and Biomedical Sciences, State University of New York at Buffalo. "More importantly, we are hopeful that with our participation and the participation of the other providers and qualified patients, AstraZeneca

will be able to find a new treatment option for patients with recurrent or metastatic squamous cell carcinoma of the head and neck."

#### Millennium's Hammonds joins NYS panel of experts for Performing Provider System Symposium

As part of the New York State Department of Health "New York DSRIP Year 1: Launching PPS Transformation Efforts" symposium held in Rye Brook, NY, Millennium Collaborative Care Executive Director Al Hammonds and Erie County Commissioner of Health Dr. Gale Burstein joined a distinguished panel of experts from across the state to discuss "Emerging Models of Successful Collaboration with County Agencies." During the session, panelists discussed best practices for collaboration between county agencies and Performing Provider Systems (PPSs), particularly within Domain 4 projects. Successful partnerships between County and PPS leadership were profiled.

Main symposium topics included: Building blocks for value-based payment; Driving toward Integrated Delivery Systems; Provider Engagement Approaches; Value-Based Purchasing in New York State; Considerations for Behavioral Health/Clinical Integration; Operational Support and Performance Resources; and Collaborative Healthcare Strategies. Breakout sessions followed the main presentations each day of the two days.

Al Hammonds previously served as chief operating officer at the Community Health Center of Buffalo (CHCB) a federally qualified health center that provides primary care, dental and behavioral health services. Prior to CHCB, Hammonds was the University at Buffalo's assistant director of outreach for the Office of Economic Development. Hammonds previously served as Deputy Erie County Executive and was also a senior project director at the Center for Industrial Effectiveness at the University at Buffalo. A certified Six Sigma Black Belt practitioner, Hammonds also served as an adjunct professor for the Empire State College FORUM Management Program. Hammonds graduated from Purdue University with a degree in industrial management and industrial engineering. He also graduated from the UCLA/Johnson & Johnson Health Care Executive Management Program. Hammonds started his career at Delphi Automotive Systems, helping to drive lean manufacturing and continuous improvement.

#### **DELIVERY SYSTEM REFORM INCENTIVE PAYMENT (DSRIP) OVERVIEW:** On April

14, 2014, Gov. Andrew M. Cuomo announced that New York finalized terms and conditions with the U.S. government for a groundbreaking waiver that will allow the state to reinvest \$8 billion in federal savings generated by Medicaid Redesign Team reforms. The DSRIP program is designed to stabilize the state's healthcare safety-net system and re-align the state's delivery system. The overarching goal of DSRIP is to help New York and its health care providers achieve the triple aim of improved population health, improved quality care, and controlled costs.

CARE: Millennium Collaborative Care is a Performing Provider System (PPS) locally chaired by ECMC, and including Kaleida Health, Niagara/Orleans PPS providers, Southern Tier PPS providers, and more than 3,800 other hospital and health-provider partners in Western New York. #### Bariatric leaders publish and present studies at conferences





## During Mental Health Month ECMC Lead Autism Training for Law Enforcement and First Responders













A parent rushes off with a kicking and screaming young child and observers believe the scene is child abduction. An individual displaying unusual behavior in a residential neighborhood is observed looking into homes and police are notified that a burglar is threatening homes. A teenager keeps moving products around on shelves in a department store and security determines that the person is in the act of shoplifting. While all of those situations may be true, it may also be as true that the persons engaged in the specific cited activities have Autism Spectrum Disorder (ASD) and the people that they first encounter, usually law enforcement or another first responder do not know that they are encountering a person with autism. To help law enforcement and first responders better recognize and understand someone who is autistic and then determine how best to interact with them, often in a crisis situation, ECMC recently hosted a training session for law enforcement and first responders about managing children, adolescents, and adults with autism in crisis situations. The two sessions were presented by ECMC, in conjunction with the Jacobs School of Medicine and Biomedical Sciences and Access to Psychiatry through Intermediate Care (APIC).

Nationally recognized authority Dennis Debbaudt was the featured presenter at today's sessions. A professional investigator and law enforcement trainer who is the father of an autistic child, Mr. Debbaudt was first to address the interactions between law enforcement and people with autism in his 1994 report Avoiding Unfortunate Situations. He has since authored or co-authored over 35 articles and books on this subject; he has also produced innovative and acclaimed training videos for law enforcement and first responders such as paramedics, fire rescue, police, and hospital staff who may respond to an autism emergency. For over two decades, Dennis has presented his multi-media training for agencies including those in the United States and overseas.

ECMC Corporation President and CEO Thomas J. Quatroche Jr., PhD, said, "Dr. Michael Cummings has been a leader in innovative and successful practices for addressing and treating autism. By convening this training opportunity for law enforcement and first responders and bringing in a respected national expert such as Dennis Debbaudt is another example of ECMC leading in creative health care techniques and practices."

ECMC Associate Medical Director, Behavioral Health Services Michael R. Cummings, MD, said, "As our efforts through initiatives like APIC have increased our ability to better understand individuals with autism, to help them, their families and loved ones, we similarly want to

Dennis Debbaudt was just the expert we wanted to join us today and help our law enforcement and first responders benefit from his depth of experience and knowledge. These types of training efforts will go a long way to building greater understanding of autism."

Dennis Debbaudt, Autism Risk & Safety Management said, "I have been training for many years and I was very happy to accept Dr. Cummings' invitation to come to ECMC and provide information that I believe will help law enforcement and first responders better understand autism and to give them a practical understanding of effective approaches when interacting with individuals affected by autism."

ECMC social worker Sheila Kennedy works directly with Prescription4Warmth and Steve and Chelsey to help distribute the warm weather gear to homeless patients who are treated at ECMC.

Frostbite so severe that it requires the removal of a limb or finger should be rare in an American city in the 21st century. But last year, two UB med students—Steve Gangloff and Chelsey Ciambella—found out how common it is among some populations. During their rotation in vascular surgery at ECMC last winter they became familiar with frostbite and its devastating consequences.

"I was actually shocked," recalled Gangloff. "I had no idea that amputations were so common. Every single day we were doing an amputation." The leading causes were diabetes and frostbite.

"I was awestruck by the fact that the disfiguring surgery was easily preventable with proper winter apparel," added Ciambella. "It was clear that there was an opportunity to better serve our community."

That realization led them to start asking frostbite patients if they owned hats or gloves. Most did not. So the students founded Prescription4Warmth, a nonprofit organization dedicated to purchasing new hats, gloves and socks for frostbite victims.

Since last year, Prescription4Warmth, through an effort with ECMC and the Lighthouse Clinic, has provided approximately 600 frostbite patients with warm hats and gloves. As a result of increased donations to the group, patients now also receive thermal socks, chapstick and information on how to avoid frostbite in the future.

Gangloff and Ciambella also treat frostbite at the Lighthouse Clinic in Buffalo, a nonprofit, drop-in clinic for uninsured patients that is managed, funded and staffed by UB medical students and faculty physicians. Most frostbite patients are uninsured and most are homeless or have a psychiatric illness. One of the worst cases at ECMC was a homeless man who had fallen asleep in the snow.

"This patient had deep frostbite in all 10 of his fingers, meaning the tissue was completely dead in each finger," Gangloff recalled. "He required an above the knuckle amputation of every finger, including his thumbs."

After surgery, the patient required physical and occupational therapy to learn how to use eating utensils specially designed for amputees.

"The surgery ultimately saved his life, because the necrotic tissue can cause sepsis and death if not treated promptly," Gangloff said, adding that once the frostbite progresses that far, there is no hope for tissue re-growth or recovery.

"He was a grateful, kind, and humble man who was very appreciative of the help we gave him," he recalled. "This encounter was one of my most emotionally moving experiences in medical school."

Gangloff and Ciambella are inductees of UB's Richard Sarkin/Medical Emeritus Faculty Chapter of the Gold Humanism Honor Society (GHHS) the national honor society of peer-selected medical students who exhibit compassion and humanism toward patients and their fellow classmates.

"Steve was asking, 'how could this happen in 2015?'" recalled Marcia Sarkin, who runs the Richard T. Sarkin Foundation for Medical Education in memory of her late husband, a UB professor of pediatrics. "It was eye-opening."

The students obtained a donation from the foundation, which supports local students inducted into the GHHS. Members of the foundation's board were supportive and solicited additional donations from alumni.

"We utilize 100 percent of donations for the purchase of warm items," said Gangloff. "We stretch the money as far as we can by purchasing items in bulk from wholesalers."

The Richard Sarkin/Medical Emeritus Faculty Chapter recently voted to include Prescription4Warmth as one of its official activities.

"Steve and Chelsey didn't just have the idea, but they also made sure that when they graduate this spring, Prescription4Warmth will continue," said Sarkin.

## Buffalo to join innovative, national program to improve health in low-income neighborhoods

The City of Buffalo has recently been selected by Reinvestment Fund and the Robert Wood Johnson Foundation to take part in the new Invest Health initiative. Invest Health is aimed at transforming how leaders from mid-size American cities work together to help low-income communities thrive, with specific attention to community features that drive health such as access to safe and affordable housing, places to play and exercise, and quality jobs.

Buffalo was selected from more than 180 teams from 170 communities that applied to the initiative. Cities with populations between 50,000 and 400,000 were asked to form five-member teams including representatives from the public sector, community development, and an anchor institution, preferably academic or health-related. The Buffalo team comprises representatives from the City of Buffalo, Erie County Medical Center, the Buffalo Urban Development Corporation, University at Buffalo, NeuWater Associates and the P2 Collaborative, and will develop a sustainable food system business with job training, community development and healthy living services at the core of the work.

"The Erie County Medical Center views the Invest Health program as a natural fit for our efforts to be a great neighbor on Buffalo's East Side," said Thomas J. Quatroche, Jr., PhD, President & CEO of ECMC. "The approach taken by the leadership team recognizes that



health is impacted by a wide variety of factors. Supporting community development, job training and job creation as well as other issues that do not fall within traditional definitions of health care is a more effective approach to driving improvements in population health. The multi-sector partners on the Invest Health leadership team will drive great improvements in this community."

Mid-size American cities face some of the nation's deepest challenges with entrenched poverty, poor health, and a lack of investment. But they also offer fertile ground for strategies that improve health and have the potential to boost local economies. The program has the potential to fundamentally transform the way Buffalo improves opportunities to live healthy lives by addressing the drivers of health including jobs, housing, education, community safety and environmental conditions.

"With a long history in community development finance, we are excited to help create a pipeline to channel capital into low-income communities through public and private investments," said Amanda High, Chief of Strategic Initiatives at Reinvestment Fund. "Our goal is to transform how cities approach tough challenges, share lessons learned and spur creative collaboration."

"Public officials, community developers, and many others have been working in low-income neighborhoods for years, but they haven't always worked together," said Donald Schwarz, MD, MPH, MBA, RWJF Vice President, Program. "Invest Health aims to align their work and help neighborhoods thrive by intentionally incorporating health into community development."


Buffalo's projects will explore a broad range of ideas from developing hydroponics, farmers' markets and aquaponics to food service jobs, community development and healthy living programs. Examples include developing a farmers' market for local residents and the creation of a healthy foods production and distribution hub that will create jobs and make affordable, healthy foods available for residents throughout the City of Buffalo. Project teams will travel to Philadelphia for a kick-off meeting on June 7th and will meet regularly to share lessons learned throughout the 18-month project. Hospital program continues to stand as the only such program in the region

On June 29, the Erie County Medical Center Corporation's (ECMCC) 9th Annual Summer Youth Internship Program held an orientation for 125 high school students who will participate in a four-week comprehensive self-development

program for area high school students administered by the ECMC Foundation. Fifty percent of the participating students come from Buffalo Mayor Byron Brown's Summer Youth Employment and Internship Program.

Buffalo Mayor Byron Brown said, "My annual summer youth employment and internship program has put thousands of young people from neighborhoods all throughout our city to work and this opportunity at ECMC will provide these high school students with real-life health care workplace experience, where they'll see firsthand the demands of a critically important work environment that has such an important impact on the lives of citizens. I am very appreciative and thankful that ECMC partnered with my Administration on this very worthy summer youth employment initiative, providing valuable work experience that will lead our children to realize a brighter future."

ECMCC President and CEO Thomas J. Quatroche, Jr., Ph.D. said, "Healthcare is a growing industry in Western New York, and ECMC is proud to play our part to educate our youth and provide opportunities to serve the patients of our community. These students are brought into the daily workings of ECMC and are provided an in-depth understanding of how our hospital functions and cares for the patients we serve. Thanks to the strong support of Mayor Brown and the ECMC Foundation, this an excellent opportunity for the students to become better acquainted with the important role hospitals play in serving our community."

The program offers summer interns a hospital-based career exploration to stimulate interest in employment in health services and to help meet the future need for qualified personnel in this field. They are required to work two (2) sixhour days for a total of 12 hours per week, which includes a hospital-based career exploration program; a heart health education program, an accident prevention course and/or a CPR certification course.

The criteria in which interns are selected to be in the ECMC Summer Youth Internship Program include: an 80% overall GPA; two letters of recommendation from their school; 14 – 17 years of age; attendance of 10th, 11th or 12th grade in the Fall of 2016, medical assessments, working papers, parent permission and a successful completion of a personal interview. ECMC's Summer Youth Internship Program is a two-year program, where participants, if they maintain the required academic GPA, can return the following summer for the second year of the summer internship.


# ECMC Women's Team Finishes 3rd in the 2016 Corporate Challenge

## Billieve Weekend Will Feature Buffalo Bills and Mobile Mammography







#### **Interesting News and Information...**

### Life in the year 2100

Based on interviews with 300 of the world's top scientists, physicist Michio Kaku assembled some predictions for what that world will look like by the turn of the next century, as published in The New Yorker the week of April 8, 2011.

One of these predictions is described below.

#### Tourists will soar into outer space via space elevators.

We will push the "up" button and the elevator will climb a long carbon-fiber cable that will extend thousands of miles into space. This will open up the solar system to wealthy tourists and the outer-space-obsessed. The key is to use nanotechnology to create super-strong cables made of carbon. In addition, scientists will be preparing the first starship capable of leaving the solar system and visiting the nearest stars. New propulsion systems, perhaps involving antimatter or fusion engines, will take us there. By the end of the century, we may have a small outpost on Mars, but an overwhelming proportion of the human race will still be on Earth. For decades to centuries to come, space travel will be for astronauts, the wealthy, and maybe a handful of hardy space colonists.
