LGBTQ+: Guidelines for Clinical Care

Overview:

This workshop will be an opportunity to learn more about guidelines for clinical care while working with people who identify as LGBTQ+. It will provide education around the demographics, stigmas, and disparities encountered in the LGBTQ+ population, language and terminology, differences between gender identity, gender expression, biological sex and sexual orientation, clinical interventions and resources available for clients, families and staff.

Learning Objectives:

- 1. Identify reasons why cultural competency in health care matters: demographics, stigmas and disparities.
- 2. Define and learn about language and terminology concerning LGBTQ+ clients.
- Introduce best practices for clinical mental health/substance abuse care of LGBTQ+ clients.
- 4. Learn the differences between gender identity, biological sex, gender expression and sexual orientation.
- Learn about different theories related to LGBTQ+ clinical practice including identity development theories, minority stress theory, micro aggressions and how stigma affects clients.
- 6. Learn about clinical interventions for work with LGBTQ+ individuals.
- 7. Learn about gender dysphoria from a narrative perspective.
- 8. Build knowledge of resources for clients, families and staff.

Instructors:

Kimberly Girdlestone is a Licensed Clinical Social Worker (LCSW-R) licensed to practice psychotherapy in New York State. She has worked with children, adolescents and adults in various clinical settings for over 20 years. Currently, Kimberly is a Psychiatric Social Worker at Erie County Medical Center working with adults in the Outpatient Behavioral Health Clinic at 1285 Main Street providing co-occurring individual and group therapies. Her passion is providing clinical care to the LGBTQ+ population. She has created two group therapy treatment curriculums for LGBTQ individuals, including a trauma treatment module. Kimberly presented on the topic of LGBTQ Clinical Care to ECMC staff as well as to Social Work students at Daemen College. She also collaborates with other treatment providers at ECMC supervising their individual and group therapy treatment of LGBTQ individuals. Prior to this position, Kimberly treated patients in ECMC's inpatient psychiatry department. In addition, she currently provides individual psychotherapy to adolescents and adults in a private practice in Amherst, NY where her practice focuses on gender and sexual minority treatment. Kimberly also specializes in providing treatment for depression, anxiety and trauma using various treatment modalities including Seeking Safety, Compassion-Focused Therapy, Mindfulness, EMDR, CBT, DBT, and Schema Therapy.

Amanda D. Pollard, MS, is an Associate Professor of Sociology at Niagara County Community College. She has presented on the issue of Gender Diversity at Niagara County Community College, Building Bridges to the Liberal Arts series, and at Canisius College.
